This letter acknowledges that the Office of Dispute Resolution and Administrative Services within the Virginia Department of Education (VDOE) received Parent's submission received on June 22, 2023.

This office is charged with the responsibility of investigating and resolving all valid special education complaints on behalf of eligible students with disabilities when the complaint alleges a violation of the applicable state and federal special education laws and regulations. The 2006 implementing regulations of the Individuals with Disabilities Education Improvement Act of 2004 (IDEA '04) outline the required components of a valid state special education complaint at 34 CFR § 300.153.

This office has reviewed the submission to determine if it meets the content requirements of the federal special education regulations. This office has determined that the submission fails to meet regulatory requirements for sufficiency (8 VAC 20-81-200.B) for the reasons denoted by an "X," below:
