Dear School Board Members,

As was requested by the Board in closed session, attached is a list of students, and their parents, who 1) are in litigation against the School Board or FCPS, or have threatened to file a lawsuit, or 2) are involved in a special education matter with FCPS. A "special education matter" ranges from an issue about placement or services that required the school or the Department of Special Services to consult legal counsel, to a complaint filed by the parent with VDOE, to a formal due process hearing before a state-appointed hearing officer. Where a matter is in active court litigation, we have listed the case number. We have also listed the school or educational program in which the student is

enrolled.
