You are in noncompliance with Virginia regulations.

VA regs dictate Letters of Inquiry (LOI) must be issued in 7 days. You took 9 days.

Your LOI states I wasn't specific in records that were withheld, yet I was very specific, to the point of now being able to prove FCPS lied about access and VDOE didn't examine evidence.

Issuing an LOI instead of a NOC was no more than another delay tactic - another way to push off a finding of noncompliance against you and FCPS.

Please follow IDEA and implementing Virginia regulations.

Please issue a NOC.

Please stop engaging in noncompliance with your own regulations.
